In accordance with the provisions of Article 12.6 of the Tender and Article 12.3.7 Para. 5) of the Rules for Applicants and Recipients - general part, version 5, within the framework of of the Operational Programme Research, Development and Education, the Contracting Authority hereby wishes to notify all the participants to the tender procedure (hereinafter referred to as the "Participant") that on the date of 24. 6. 2019 it decided on the selection of a contractor for the aforestated public contract.

Justification:

The bids were assessed in accordance with their value for money. When assessing the value for money the Contracting Authority proceeded in accordance with the **lowest offer price**. The bid price which was the lowest within the framework of all evaluated bids was assessed as the best one;

Its total value in CZK exclusive of VAT for the entire subject matter of the public contract as stated within the draft purchase contract was decisive when evaluating the proposed price. The order of the bids was compiled in an ascending order from the lowest to the highest bid price.

The outcome of evaluation of the bids

Since only a single participant took a part in the selection procedure, it was selected by the Commission without performing the evaluation.

The selected contractor is **PowderPro Göteborg AB**, with registered office in Barken Storegrunds gata 1, 41760 Göthenburg, Sweden, Co. Reg. No.: 556633-9460.

The proposed price of the selected contractor amounts to CZK 1,255,500 exclusive of VAT.
