The contracting authority, in accordance with the provisions of Section 50 and Section 53(5) of Act No. 134/2016 Coll., on Public Procurement, as amended (hereinafter the "Act"), hereby informs all participants in the procurement procedure (hereinafter referred to as "participant") that on 12 June 2025, it decided to award the above-mentioned public contract, procured in the simplified below-threshold procedure pursuant to Section 53 of the Act, to the following participant.

#### **Justification:**

In accordance with the provisions of Section 39(4) of the Act, the Commission evaluated the bids before assessing the bids. After evaluating the bids, the Commission assessed the fulfilment of the conditions for participation in the tender procedure only for the participant whose bid was assessed as the most advantageous..

The offers were evaluated according to their economic advantage. The economic advantage of the offers was evaluated according to the lowest offer price. The offer price that was the lowest among all the evaluated offers was evaluated best.

When evaluating the bid price, the decisive factor was its total amount in CZK excluding VAT for the entire subject of the public contract performance specified in the draft contract (Article VII. Paragraph 1 of the Invitation to Submit a Bid including the tender documentation). The order of the bids was compiled in ascending order from the lowest to the highest bid price.

In accordance with the chosen evaluation criteria, the committee established the following ranking::
