Justification for the cancellation of the procurement procedure where such case occurred:
<p>The contracting authority cancelled the procurement procedure for this Lot of the above-mentioned public contract pursuant to Section 127(2)(d) of the Act, as during the procurement procedure for this lot of the public contract the grounds which merit particular consideration have occurred and on the basis of these grounds the Contracting Authority cannot be required to continue the procurement procedure.</p> <p>The contracting authority received two tenders for this lot of the public contract. During the tender evaluation, it was found that both tenders contained identical tender prices. The contracting authority did not set rules for the case of equal tender prices among tenders with the lowest tender price, the contracting authority concludes that this situation constitutes grounds which merit particular consideration, due to which it cannot be reasonably required of the contracting authority to continue the procurement procedure for this lot of the public contract. Under the circumstances at hand, it is not possible, if the procurement procedure for Lot 2 of the public contract were to continue, to guarantee proper and indisputable compliance with all public procurement principles under Section 6 of the Act, in particular the principles of transparency and non-discrimination, especially when completing the evaluation phase and subsequently selecting the contractor.</p> <p>For these reasons, the contracting authority decided, pursuant to Section 127(2)(d) of the Act, to cancel the procurement procedure for Lot 2 of the public contract.</p>
