## **Justification:**

The bids were evaluated in accordance with their value for money. When assessing the value for money the Contracting Authority proceeded in accordance with the **lowest offer price**. The bid price which was the lowest within the framework of all evaluated bids was assessed as the best one.

Its total value in CZK exclusive of VAT for the entire subject matter of the public contract as stated within the draft purchase contract was decisive when evaluating the proposed price. The order of the bids was compiled in an ascending order from the lowest to the highest bid price.
